FUND MANAGER COMMENTARY

Risk assets had a poor end to the year, with December witnessing lower equity prices and wider credit spreads. This was despite the US and China postponing the next round of trade tariffs at the beginning of the month. European assets generally outperformed, while government bond yields were lower and the US dollar weaker over the course of December, with futures no longer pricing in any US rate hikes for 2019.

The fund delivered negative returns in December, with our holdings in investment grade bonds detracting from performance. While we continue to run a defensive credit portfolio overall, we moved tactically more constructive on US investment grade credit over the month. In rates positions, our relative value trade of long the front end of the European curve versus a short in the US front end detracted from performance, but we maintained the position. In terms of currencies, we retained a long bias to the US dollar.

Valuations have corrected a long way in a short period of time, and it is therefore possible for markets to recover somewhat should macro conditions stabilise, particularly if the Fed offers some verbal support. But a significant increase in corporate bond issuance is likely at the start of 2019. We'd therefore expect things to get worse before global central banks turn on their support once again and markets are able to rally sustainably.

Julien is a portfolio manager in the Multi-Strategy Fixed Income team where he is responsible for global credit and absolute return mandates. He joined LGIM in September 2007 from Fortis Investments, where he was a quantitative strategist in the structured finance team and developed market standard and proprietary models for the pricing and risk management of credit derivatives as well as trading and hedging strategies. Julien has a PhD in financial modelling from the Ecole Normale Supérieure, Paris, France.

KEY RISKS
