What is the product?

Type: This investment fund is a Unit Linked Fund within a life insurance policy.

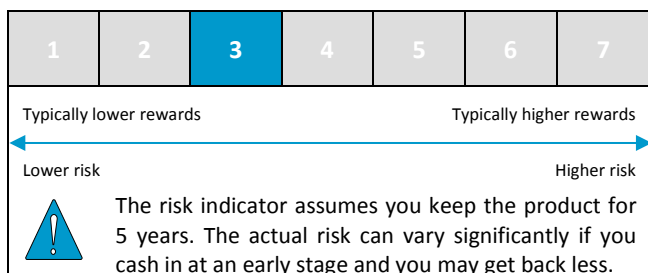
Objectives: The fund aims to achieve growth of capital and provide income. Income from investments will be reinvested into the fund.

The investment objective of the fund is currently to produce a total return in line with the performance of the FTSE Actuaries UK Conventional Gilts All Stocks Index and capture the yield spread over gilts of AAA-AA rated fixed interest securities.

The fund is passively managed following a buy and maintain strategy and does not track a specific index. The fund is primarily invested in corporate bonds, i.e. debt issued by UK or overseas companies issued in sterling. The fund invests primarily in fixed interest securities, where income is pre-set at a fixed level. The fund predominantly includes securities that are AAA or AA rated and constituents of the Markit iBoxx £ Non-Gilt Sovereign & Sub-Sovereign AAA-AA Index, following issue. Third party credit ratings give an indication of how likely it is that an issuer of a bond will be able to fulfil its contractual obligations to pay back interest and capital on the loan on time, AAA rated being those with the highest credit quality. The fund either invests directly in the securities, or indirectly through other LGIM funds. The fund may also hold gilts to provide liquidity and to ensure that the fund's duration remains within tolerance of the FTSE Actuaries UK Conventional Gilts All Stocks Index.

Intended retail investor: The trustees of UK registered and certain non-UK registered defined benefit or defined contribution occupational pension schemes, which may be classified as either retail clients or professional clients.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10,000 GBP. The figures are estimates and may change in the future.

Ongoing costs	Portfolio transaction costs	0.001%	The impact of the costs of us buying and selling underlying investments for the product.
	Other ongoing costs	0.13%	The impact of the costs that we take each year for managing your investments.
Incidental costs	Performance Fee	0%	The impact of performance fees. We take these from your investment if the product outperforms its benchmark.

How long should I hold it and can I take my money out early?
