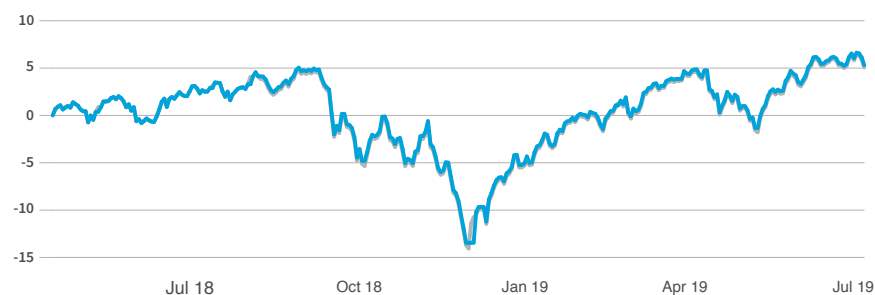

### INDEX FUND MANAGEMENT TEAM
