What is the product?

Type: This investment fund is a Unit Linked Fund within a life insurance policy.

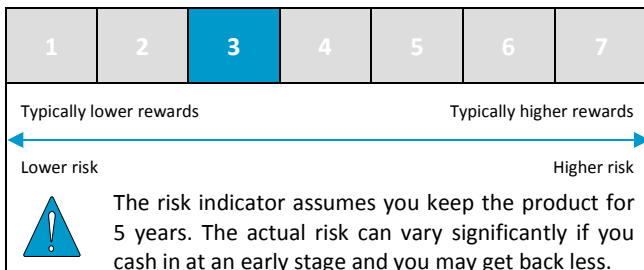
Objectives: The fund aims to achieve growth of capital and provide income. Income from investments will be reinvested into the fund.

The investment objective of the fund is currently to produce a total return in line with the performance of a subset of the FTSE Actuaries UK Conventional Gilts Over 15 Years Index, this being the gilts with maturities of 15 to 35 years and capture the yield spread over gilts of AAA-AA rated fixed interest securities.

The fund is passively managed following a buy and maintain strategy and does not track a specific index. The fund is primarily invested in corporate bonds, i.e. debt issued by UK or overseas companies issued in sterling. The fund invests primarily in fixed interest securities, where income is pre-set at a fixed level. The fund predominantly includes securities that are AAA or AA rated and constituents of the Markit iBoxx £ Non-Gilts Sovereign & Sub-Sovereign AAA-AA Over 15 Years Index, following issue. Third party credit ratings give an indication of how likely it is that an issuer of a bond will be able to fulfil its contractual obligations to pay back interest and capital on the loan on time, AAA rated being those with the highest credit quality. The fund either invests directly in the securities, or indirectly through other LGIM funds. The fund may also hold gilts to provide liquidity and to ensure that the fund's duration remains within tolerance of the FTSE Actuaries UK Conventional Gilts 15-35 Years Index.

Intended retail investor: The trustees of UK registered and certain non-UK registered defined benefit or defined contribution occupational pension schemes, which may be classified as either retail clients or professional clients.

What are the risks and what could I get in return?

What are the costs?
