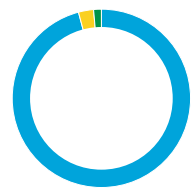

FUND MANAGER COMMENTARY

Euro Corporate Bond – OEIC/SICAV April was another very strong month for global markets. While subdued compared to 2018’s tax-cut-boosted growth rates, the first quarter earnings season started off strongly, with US earnings coming in significantly ahead of expectations, helping push the S&P 500 to new all-time highs. While still some way from their highs, European assets generally outperformed, catching up from earlier in the year.

The portfolio performed well amid the strong rally in markets and the fourth month of credit spread tightening in a row in 2019. It was also a relatively strong month for European issuance, but technical market conditions remained supportive, with most of the new deals being oversubscribed by investors. From an attribution perspective we managed to add additional performance mostly through off-benchmark issues in additional tier-1 names and high yield bonds.

Looking ahead, valuations are starting to appear stretched, and are increasingly pricing in a goldilocks environment of modest growth and supportive monetary policy. In the shorter term, a setback in either – such as accelerating inflation, or rising geopolitical tensions – would likely result in a market correction. The focus is on valuations getting less attractive in the current ‘search for yield’ environment.

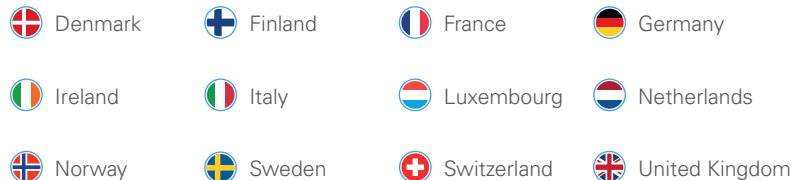
