What is the product?

Type: This investment fund is a Unit Linked Fund within a life insurance policy.

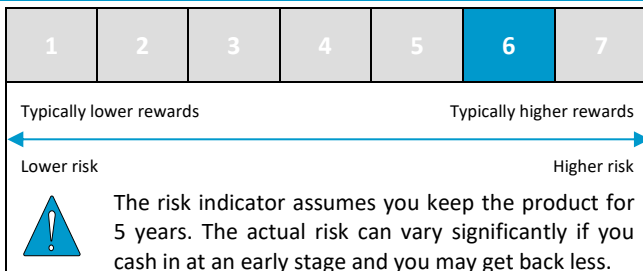
Objectives: The fund aims to achieve growth of capital and provide income by allowing the fund manager the discretion to take active investment decisions. Income and principal from investments will be distributed monthly by the cancellation of units.

The objective of the Fund is to capture the return received as a result of taking credit risk through investing principally in a globally diversified portfolio of non-government bonds and avoiding investment in bonds which in the opinion of the Investment Manager are likely to default or experience a significant deterioration in credit quality.

The fund will achieve all of its exposure by purchasing shares in the LGIM Maturing Buy & Maintain Credit Fund 2020-2024 (the "Underlying Fund"), a sub-fund of LGIM (Ireland) Risk Management Solutions PLC, an umbrella investment company with variable capital incorporated in Ireland. The Underlying Fund will aim to predominantly purchase non-government bonds, all with expected principal payments to be paid between 1st Jan 2020 and 31st Dec 2024. The Underlying Fund is predominantly invested in securities that are investment grade, i.e. rated as lower risk. Investment grade bonds have achieved a higher credit rating (BBB- and above) from a recognised rating agency. The Underlying Fund has a limit of 10% for sub-investment grade bonds, i.e. those rated as higher risk. Sub-investment grade bonds have achieved a lower credit rating from a recognised rating agency. Third party credit ratings give an indication of how likely it is that an issuer of a bond will be able to fulfil its contractual obligations to pay back interest and capital on the loan on time. The Underlying Fund can hold cash and invest in money market products. Where investments are issued in currencies other than sterling currency hedging may be employed to protect against exchange rate and interest rate movements between those currencies and sterling. The Underlying Fund may also hold derivatives, (contracts which have a value linked to the price of another asset) such as interest and inflation swaps, credit default swaps, futures and currency forwards currently for efficient portfolio management i.e. to reduce risk or cost, or to generate additional income with acceptably low level of risk. The fund will pay-out all coupon payments and expected principal payments.

Intended retail investor: The trustees of UK registered and certain non-UK registered defined benefit occupational pension schemes, which may be classified as either retail clients or professional clients.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 6 out of 7, which is the second-highest risk class.

The figures do not take into account your personal tax situation, which may also affect how much you get back.

Market developments in the future cannot be accurately predicted. The scenarios shown are only an indication of some of the possible outcomes based on recent returns. Actual returns could be lower.

What happens if Legal and General Assurance (Pensions Management) Limited is unable to pay out?

PMC's floating charge is intended to operate to protect PMC policyholders, by maximising their likely recoveries, if PMC were to become insolvent. In addition, in the event of PMC's insolvency certain PMC policyholders may be able to recover up to 100% of any deficit (any shortfall of the value of a valid claim for any loss incurred after the operation of PMC's floating charge) from the FSCS. Please note that PMC policyholders would have to meet the relevant FSCS eligibility criteria to claim. Your ability to claim and the amount you may be able to claim under the FSCS will depend on the specific circumstances of your claim. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs, but exclude the Policy Charge relevant to you.

The amounts shown here are the cumulative costs of the Fund, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10,000 GBP. The figures are estimates and may change in the future.

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs and show you the impact that all costs will have on your investment over time.
