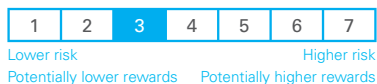

The fund aims to provide diversified exposure to sterling assets that reflect the broad characteristics of investments underlying the pricing of a typical inflation-linked annuity product.

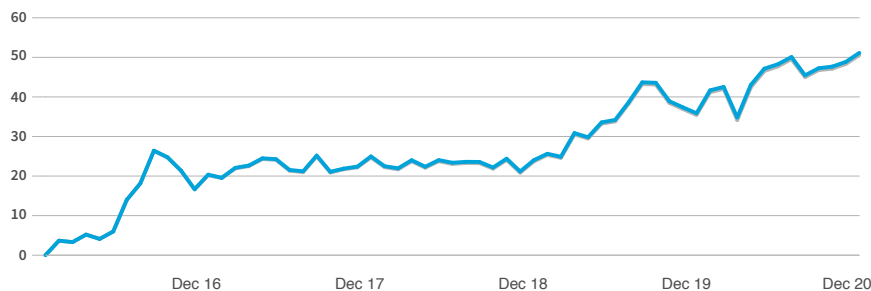
WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

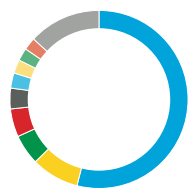
The fund invests in LGIM's index-tracking bond funds and aims to improve potential outcomes for investors likely to purchase inflation-linked annuities, by providing diversified exposure to fixed interest and inflation-linked bonds. The fund, however, cannot provide full protection against changes in inflation-linked annuity rates for individual members since these also depend upon a number of other factors (e.g. its assets are not sensitive to changes to mortality assumptions). The asset allocation is reviewed quarterly by the Portfolio Solutions team and the fund will not take short-term, tactical asset allocation positions.

Benchmark note

The benchmark asset allocation for the Fund is a composite of gilts and corporate bond funds.

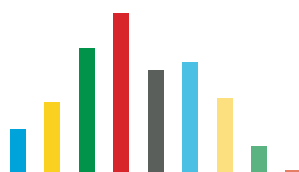

FUND MANAGERS

The Fund's strategic asset allocation is set and maintained by LGIM's Portfolio Solutions team. This team has a wealth of experience and is drawn from financial, actuarial and consultancy backgrounds. They are involved in asset allocation work for a wide range of LGIM's clients, typically large pension and insurance funds.

The allocation is managed by the Allocation Strategy Management team. Management oversight is provided by the Director, Allocation Strategy Management. The team of 10 has an average industry experience of 13 years, of which six years has been at LGIM.

KEY RISKS

- PMC seeks to mitigate counterparty risk wherever possible on behalf of its policyholders through a variety of measures which include: each fund's non-cash assets being held with independent custodians, sweeping cash (where appropriate) overnight into the LGIM's range of Liquidity funds (above a deminimus level), using the delivery versus payment system when settling transactions and the use of central clearing for exchange traded derivatives and forward foreign exchange transactions. However, in the event of the failure of a counterparty, custodian or issuer there is a residual risk that a fund may suffer asset losses which are unrecoverable.
