## FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 5% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

## FUND SNAPSHOT

- **What does it invest in?** Invests at least 80% in shares of UK companies which are considered to be undervalued by the market, where the Manager believes there to be a catalyst (a feature or market event) which should increase the value of the company.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.

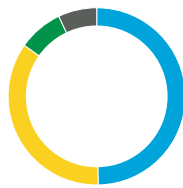

## FUND MANAGER COMMENTARY

The UK equity market performance was mostly negative amid the rise of new coronavirus cases across the UK and Europe, with many governments announcing a second lockdown. The growing prospect of a hard Brexit added to the broader uncertainty on the implications for economic recovery. More near term, the lack of fiscal stimulus ahead of the upcoming US election vote applied downward pressure on markets. In terms of economic data, August UK GDP (gross domestic product) slowed significantly, though was in line with our expectations. From a bottom-up perspective, Q3 corporate earnings have generally beaten expectations thus far, but the market appears more focused on Q4 guidance and the 2021 outlook. As such, good results are not necessarily being rewarded on results day.

The L&G UK Special Situations Trust outperformed its benchmark. Stock selection was negative with weakness in Financials and Oil & Gas. Sector allocation was more beneficial, led by positive contributions from the underweight positioning in healthcare and consumer goods. At the individual stock level, the top performers included Blue Prism, NatWest Group and Triam Investors. Underperforming names included Prudential, Energean and Grit Real Estate Income Group. There was no notable new activity in the period.

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>ii</sup>.
