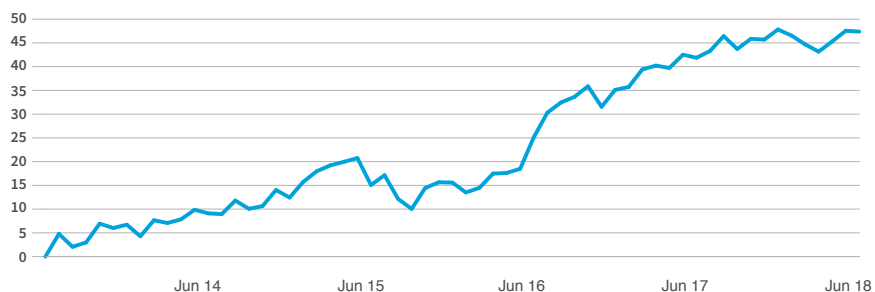
WHO IS THIS FUND FOR?

Please note that the Fund's allocation and comparator changed with effect from 31 July 2016. Comparator returns for periods starting before this date include an internally calculated composite benchmark composed of the benchmarks for each constituent fund that the Consensus Index Fund held. The Consensus Index Fund invested in a range of funds to follow the average distribution of the Balanced Fund, excluding Property as published in the CAPS Pooled Pension Fund Update.

FUND CHARACTERISTICS

The fund will invest in a range of assets which may include equities, bonds, cash and listed infrastructure, private equity and global real estate companies. Exposure to each asset class will primarily be through investing in passively managed funds. The assets of the fund may be held directly or indirectly via units of other PF Sections, including MPAA (Multi-Asset Fund), deemed by PMC to be relevant to the objective of the fund. The fund aims to meet the criteria of the ABI Mixed Investment 40-85% Shares Sector. The fund is expected to have a level of risk which is equivalent to two thirds of the volatility of a global equity portfolio, over the long-term.

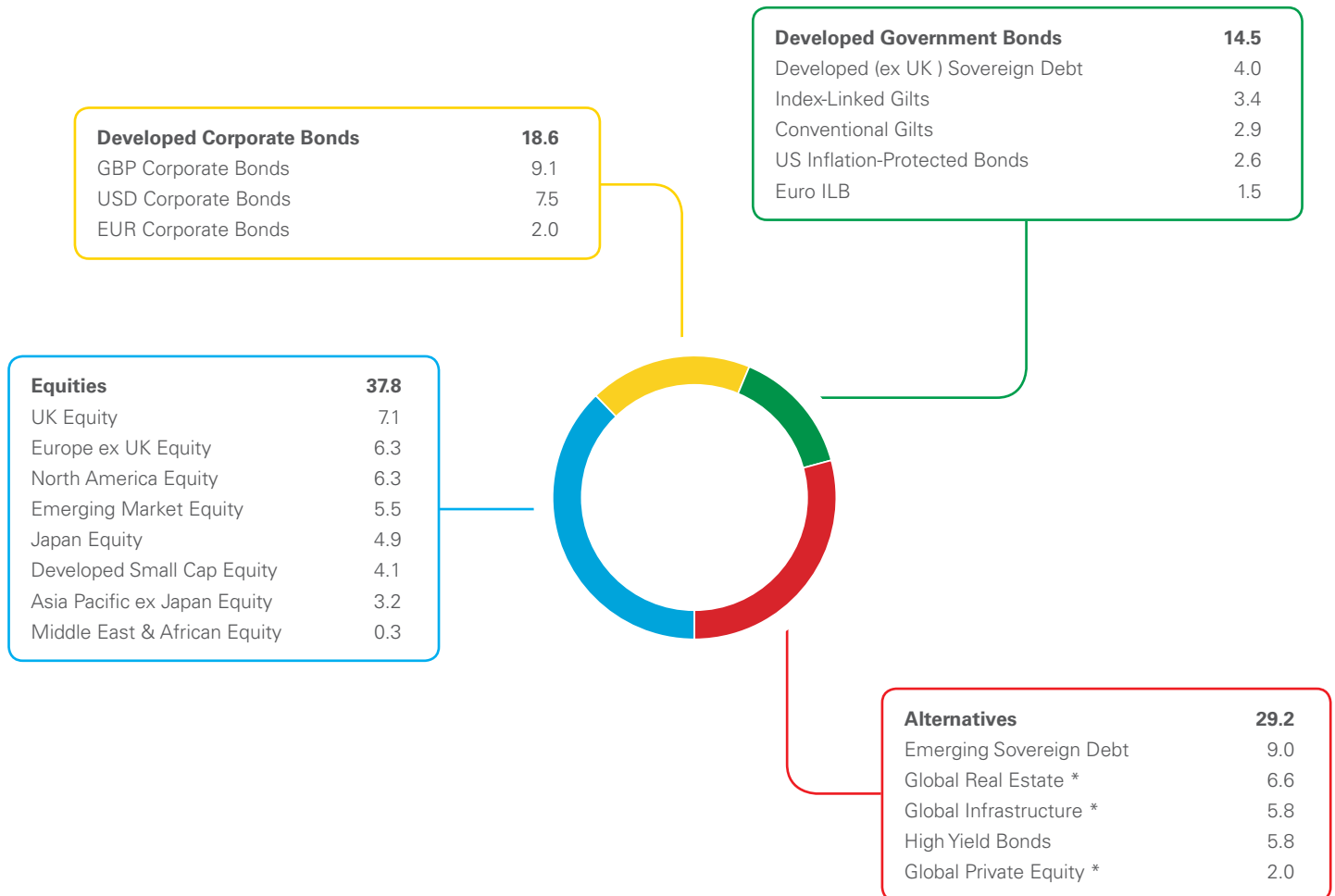
Comparator note

The diversified nature of the Fund means that it is expected to have less exposure than a pure equity fund to adverse equity market conditions. However, the Fund may perform less strongly than a pure equity fund in benign or positive market conditions.

Please note that the performance data for the ABI Sector is on a 1 day lag and does not exactly correspond with the time period of the performance data for the Fund, the effect of this should even out over longer time periods, but may be pronounced over short time periods.

FUND MANAGER COMMENTARY

Market headlines over the quarter were dominated by escalating concerns over European politics and trade conflict between the US and China. However, this didn't result in universally poor performance for risk assets. Emerging market assets and European peripheral debt were the worst performing assets. However, UK and US equities performed well, REITs and listed infrastructure turned around their disappointing start to the year, while European and Japanese equities edged higher. The decline in sterling was notable, helping to boost returns on unhedged overseas assets. In fixed income markets, there was a clear upward trajectory in US interest rates, while pan-European rates generally fell in response to caution from the European Central Bank.

The Multi-Asset Fund delivered positive returns in the second quarter. Risk assets, with the exception of emerging market assets, performed well over the second quarter with REITs, infrastructure, North American equities and global small-cap equities contributing the most to performance. In contrast, emerging market equities, emerging market debt and US credit detracted from performance.

During the quarter we undertook portfolio rebalancing and marginally increased exposure to sterling corporate bonds and 'fallen angels' (a sterling credit index that retains downgraded bonds). In contrast, we reduced exposure to UK equities and Europe ex UK equities.

FUND MANAGERS

The Fund is managed by LGIM's Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM's client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
