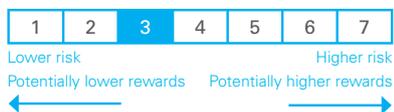


WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

The fund may achieve all or a significant amount of its exposure by purchasing shares in the LGIM Global Corporate Bond Fund which is a UCITS Compliant OEIC sub-fund. The underlying fund will principally invest in a variety of fixed, floating, index-linked and zero coupon government bonds and corporate bonds, other fixed or floating debt securities that may include Asset-Backed Securities (ABS), hybrid bonds, shares in the sub-funds of LGIM Liquidity Funds Plc. and other cash and money market instruments. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the Fund.



FUND MANAGER COMMENTARY

Credit markets rebounded dramatically from their March slump, significantly outperforming government bond markets during the second quarter. Optimism over the potential for global economic activity to recover sharply as COVID-19 lockdowns are eased and confidence that a vaccine could be developed earlier than had been expected boosted investors' risk appetite.

Performance was positive over the quarter, driven by positive outcomes from rates, asset allocation and credit strategies. We increased credit exposure, and to US dollar credit in particular, in late March and through April, as we were comforted by the wide credit spreads as well as the support for fixed income assets from central banks. This benefited the portfolio as credit markets, particularly US dollar credit, had a strong recovery from a challenging first quarter.

Exposure to higher yielding parts of the fixed income markets, such as emerging markets and high yield, also contributed to performance, as those areas recovered sharply from their first-quarter underperformance. We also increased exposure to cyclical names and sectors during the quarter, which benefited from a compression in spreads amidst the broader rally. Existing positions which had underperformed in the first quarter, such as energy and subordinated European peripheral bank debt, recovered strongly as well as investors sought to purchase high-yielding bonds.

While we have reduced our bullish credit view somewhat as valuations have tightened and infections have increased, current monetary and fiscal support argues against an outright bearish stance for global credit.
