The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited.

OBJECTIVES AND INVESTMENT POLICY

- The objective of this Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 3% per annum before charges, over rolling three year periods.
 - The Fund is actively managed and invests at least 90% in the shares of UK companies. These are companies that are incorporated, headquartered or which have their principal business activities in the UK, or companies that are listed in the UK and constituents of the Benchmark Index.
 - Over a market cycle (typically 3 to 5 years), the Fund will comprise of 30 to 60 companies selected by the Manager as representing their highest conviction ideas following detailed research. At times the Fund's portfolio may be concentrated.
 - The Manager is allowed significant discretion and the weight of an individual company can represent from -10% to +5% of the Index weight. For example, if a company represents 4% of the Index, the fund can hold from 0% up to 9% of fund assets in that company. In addition, the Manager has discretion to hold -10% to +10% of the Index weight in any sector. This will mean that the return of the Fund and the Index will be different over short periods of time and the tracking error can range from 3% to 9%.
 - The Fund may also invest in collective investment schemes including those managed or operated by the Manager or an associate of the Manager as well as participatory notes, preference shares, cash, deposits and money market instruments (such as treasury bills).
 - In addition, the Fund is also permitted to receive and hold warrants and convertible bonds as a result of corporate actions.
 - The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:
 - reduce risk or cost; or
 - generate additional capital or income with no, or an acceptably low, level of risk.
- Other information:**
- Your units will be accumulation units. Income from the Fund's investments (dividends) will be reinvested back into the value of your units.
 - You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price.
 - The Fund's base currency is denominated in sterling (British pounds).
 - This Fund is designed for investors looking for growth from an investment in UK companies.
 - Although investors can take their money out at any time, this Fund may not be appropriate for those who plan to withdraw their money within five years.
 - This Fund is not designed for investors who cannot afford more than a minimal loss of their investment.
 - If you do not understand this document we recommend you seek additional information to help you decide if this Fund is right for you.

- The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. 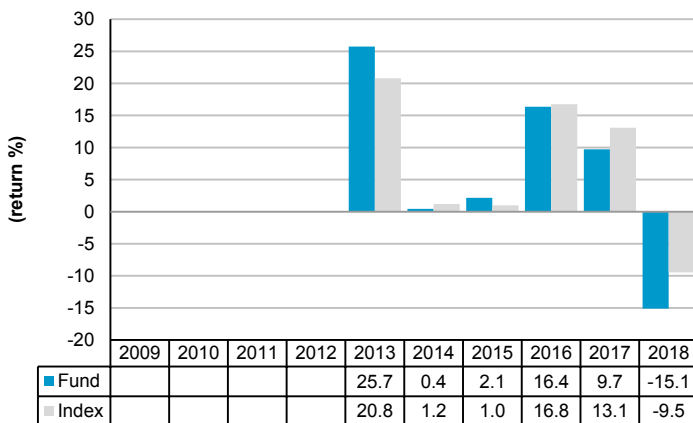
CHARGES

- There are no entry or exit charges.
 - The ongoing charges figure is based on the latest available expenses at December 2018. This figure may change in the future.
 - This Fund's ongoing charges include any charges made by any other funds it may invest in. They exclude portfolio transaction costs.
 - The ongoing charges are taken from the income of the Fund.
- Other costs:**
- **Dilution levy:** Each day the Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the fund's assets. In certain circumstances, if necessary to protect ongoing investors, we can also take a deduction from anyone buying or selling units. This deduction is called the 'dilution levy' and reflects the difference between the buying and selling prices of the assets in the Fund and costs associated with buying and selling the assets.
 - The dilution levy is separate to the ongoing charges shown in this section.
 - As an example, the dilution levy for this Fund was 0.56% for purchases and 0.08% for sales at 31 December 2018. The amount of the dilution levy may differ in future.

PAST PERFORMANCE

- The Fund now aims to outperform the Benchmark Index by 3% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.
- The annual return is for a 12 month period ending 31 December.
- The Fund launched in 1996.
- This unit class launched in 2012.
- The performance benchmark for this Fund is the FTSE All-Share Index.
- On the 1 November 2018 the Fund's objective and investment policy changed to increase the performance target. Prior to this date, the equivalent performance target was to achieve a return of 0.25% or greater over the benchmark. From this date, for this unit class and allowing for charges, if the fund has achieved a return, over rolling three periods of 2.00% per annum or greater over the benchmark, it has achieved its performance target.
