## FUND AIM

The Fund's objective is to provide a combination of growth and income within a pre-determined risk profile. The Fund's potential gains and losses are likely to be constrained by the aim to stay within the risk profile. The Fund also aims to incorporate environmental, social and governance considerations into the investment strategy.

## WHO IS THIS FUND FOR?

- This fund is primarily designed for investors: who have received advice and had their attitude to risk assessed and matched to the risk profile of this fund but may be appropriate for those investors who have considered the risk profile of this fund with the others in the Multi-Index range; who are looking for growth and income from an investment in bonds, shares in companies, money market instruments, deposits, cash and indirectly to alternative asset classes (such as commodities) and property.
- Although investors can take their money out at any time, this fund may not be appropriate for those who plan to withdraw their money within five years.
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment.

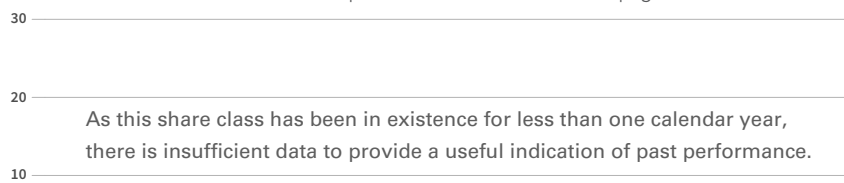

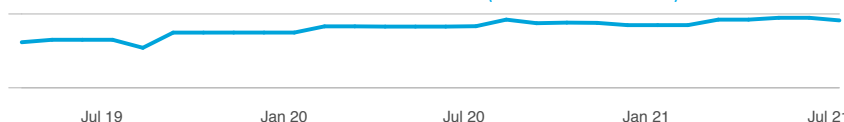

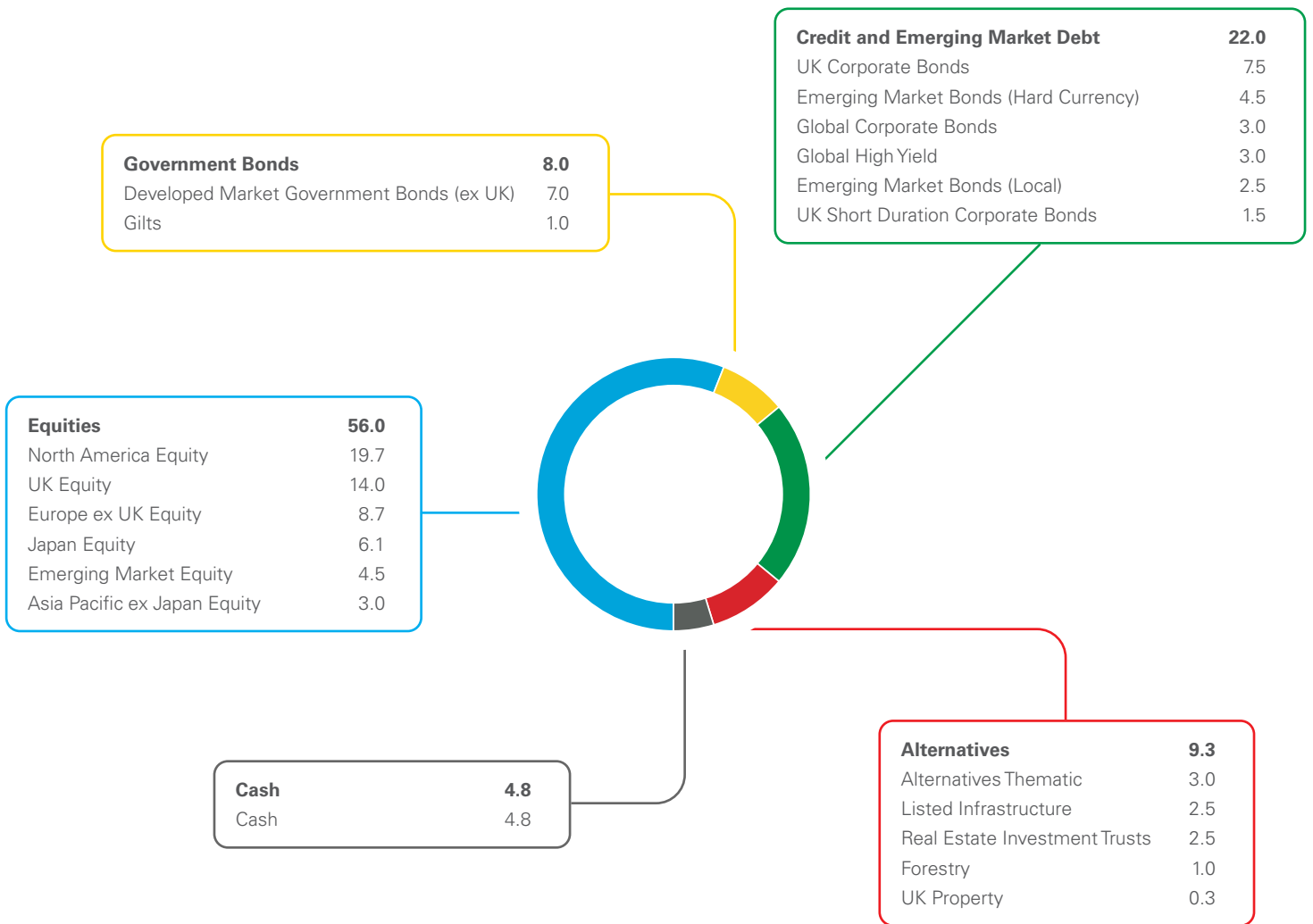

## ESG COMMITMENT

From diesel emissions to oil spills, there have been many tangible examples in recent years of how failures in the way companies are run can have a harmful impact on the environment, society and investor returns. ESG score of fund

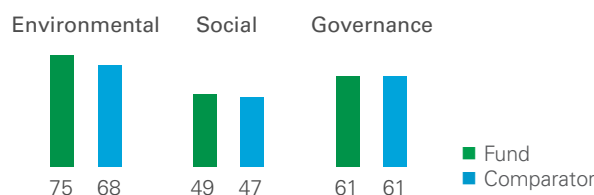


ESG score of comparator

### ESG SCORE

We score companies based on environmental, social and governance factors. The ESG Score is aligned to our engagement and voting activities. As a result, this portfolio has an aggregate ESG Score of **59** versus a mainstream comparator of **55**.

ESG scores and carbon metrics are calculated for the portion of the portfolio that invests in LGIM's Future World funds.



## ENVIRONMENTAL PERFORMANCE

Carbon dioxide (CO<sub>2</sub>) is the most significant contributor to greenhouse gas emissions which are driving climate change. Compared to the unadjusted comparator, the fund will have a different exposure to current and future sources of carbon dioxide emissions.

### CARBON RESERVES INTENSITY

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figures below are a measure of the size of carbon reserves held by the fund's underlying companies.

The fund has **84%** lower carbon reserves intensity<sup>ii</sup> compared to the unadjusted comparator.

The difference in carbon reserves intensity means that for every \$1 million invested in the fund, the exposure to carbon reserves through the underlying companies is reduced by an amount equivalent to **1307 tonnes of CO<sub>2</sub>e** compared to having invested in the unadjusted comparator.

### CARBON FOOTPRINT

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

The fund has **45%** lower carbon footprint compared to the unadjusted comparator. Carbon footprint describes the relationship between the carbon emissions of a company and its EVIC<sup>iii</sup>.

The difference in carbon footprint means that the fund has selected companies where, for the same level of EVIC, the associated emissions<sup>iv</sup> are lower by **29 tonnes of CO<sub>2</sub>e** compared to the unadjusted comparator<sup>v</sup>.

## NOTES

<sup>i</sup> Carbon dioxide equivalent (CO<sub>2</sub>e) is a standard unit to compare the emissions of different greenhouse gases.

<sup>ii</sup> This metric looks at the embedded carbon in the fossil fuel reserves owned by a company, divided by a company's enterprise value (including cash), to adjust for company size. This represents a carbon reserves intensity score for a company.

<sup>iii</sup> The choice of this metric follows best practice recommendations from the Task Force on Climate-related Financial Disclosures.

<sup>iv</sup> Data on carbon emissions from a company's operations and purchased energy is used.

<sup>v</sup> This measure is the result of differences in the weights of companies between the index or the fund and the comparator, and does not depend on the amount invested in the fund. It describes the relative 'carbon efficiency' of different companies in the comparator (i.e. how much carbon was emitted per unit of sales) or in the fund, not the contribution of an individual investor in financing carbon emissions.

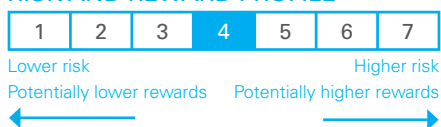

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 4 because the mix of different asset types in which the fund invests has a balancing effect on the rate at which the fund share price moves up and down.

KEY RISKS
