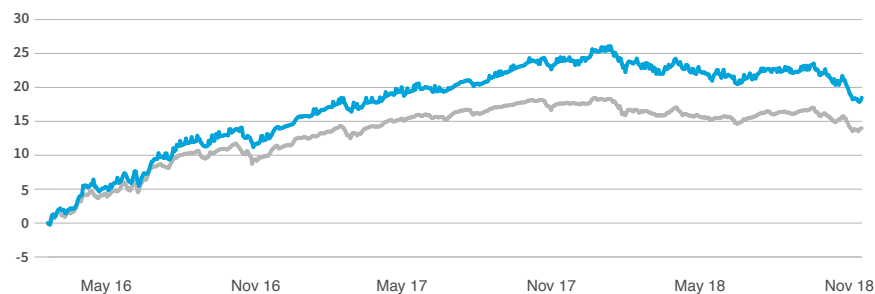

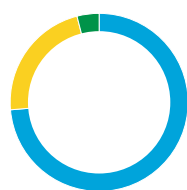

## FUND MANAGER COMMENTARY

The high yield market moved lower in November, as a broader weakness in risk assets continued. The fund underperformed the benchmark over the month. There were multiple negative headlines, including Italian politics, Brexit, trade wars, the weakness of General Electric and Chinese growth deterioration. However, outside of the headlines, the withdrawal of global liquidity continues to be a major driver of market weakness with quantitative tightening weighing on investor sentiment.

During the month we looked to reduce exposure to single B bonds in Europe where we see greater downside risk, and we are now underweight the benchmark in European high yield. Regionally the fund has moved from being marginally underweight to marginally overweight in North America, where we continue to see robust economic growth. We have maintained our small overweight in emerging markets where credit quality is improving and valuations are attractive in our view.

Looking ahead, we see a tougher economic environment in Europe, although there remains likelihood of reasonable growth in the USA. Defaults seem likely to rise in Europe and will be materially higher than in the USA in our view.

Martin Reeves is Head of Global High Yield. Prior to joining LGIM in 2011, Martin ran Credit Research at AllianceBernstein where he had worked since 1998. Prior to Alliance Bernstein Martin was Head of US High Yield Research at UBK Asset Management and a Chartered Accountant with Ernst & Young. Martin holds an MA in Economics from Cambridge University, St Catharine's College.

## KEY RISKS
