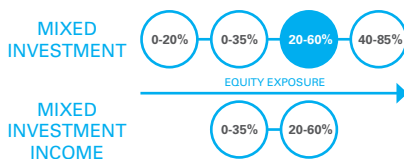

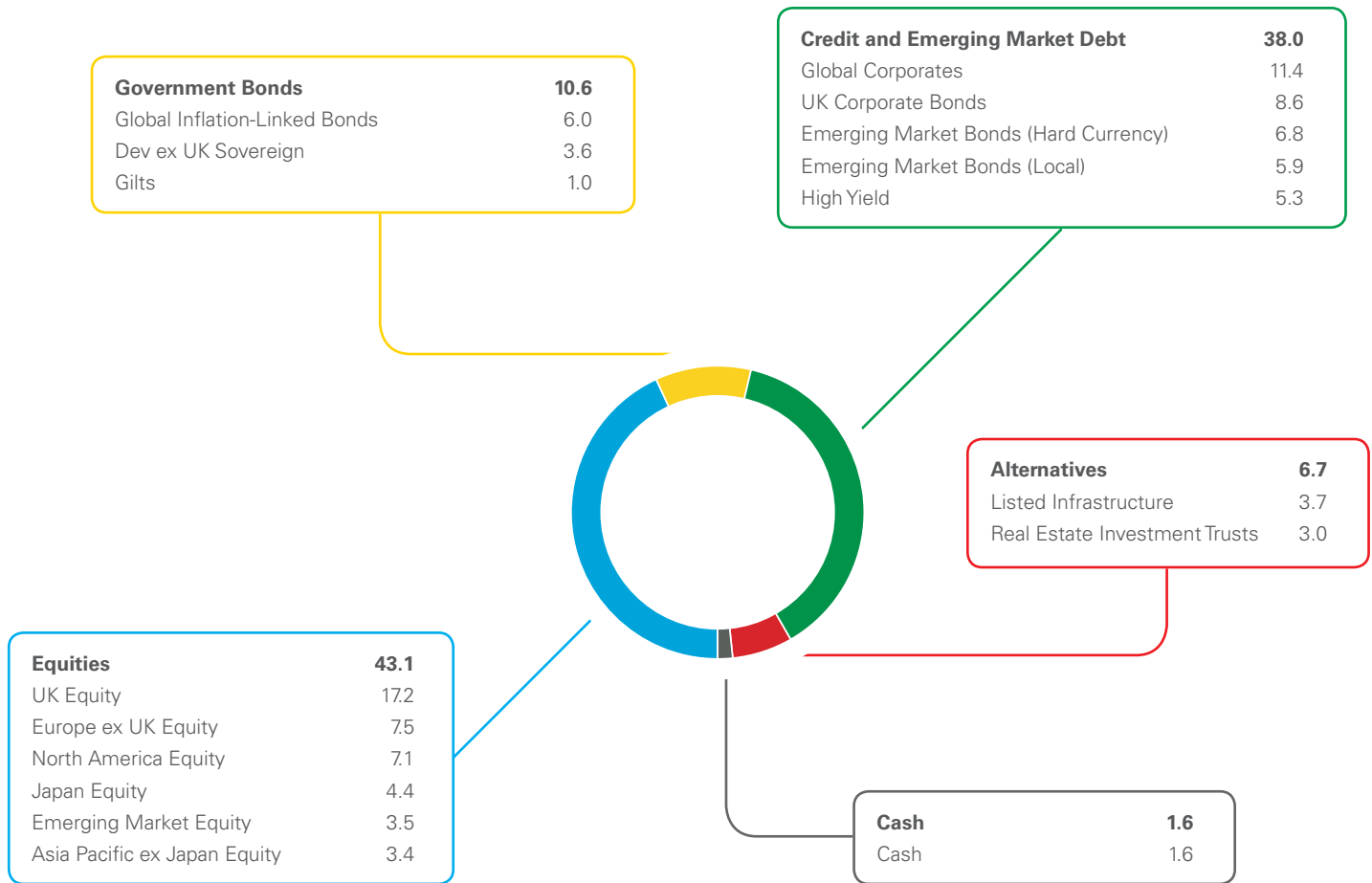
## FUND SNAPSHOT

## RISK AND REWARD PROFILE

## KEY RISKS
