FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

- **How does it invest?** Actively managed, with holdings in between 40 and 60 companies on average over a typical market cycle of 3-5 years.

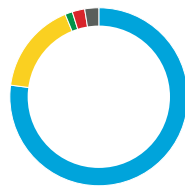

FUND MANAGER COMMENTARY

The UK equity market produced a positive return in February. Beneath the surface, volatility continued from January, with rising rates and the reopening trade resulting in value and cyclical stocks enjoying a strong month. Materials and Oil & Gas stocks were particularly strong. Growth and quality names continued to underperform, continuing the factor rotation that began towards the end of January. Investors are closely monitoring oil prices, which continued to gain momentum, returning +20% in the period. The success of UK's vaccine program continues fuel positive market sentiment, with 20 million people having now received their first dose. In terms of company results, earnings season has for the most part surpassed analyst expectations across the board. However, given the volatility, market reactions have varied.

The L&G UK Equity Income Fund outperformed against its benchmark in February. Stock selection contributed to the outperformance, driven by our names in Financials and Consumer Services. Sector allocation was also positive, with the fund benefitting from an underweight positioning in Health Care and Consumer Goods. By stock, the strongest performers were easyJet and Whitbread. Being underweight in Unilever was also positive. Underperforming names included Imperial Brands and Next.

There were no notable portfolio changes in the period.

Stephen joined LGIM in 2017 as a Fund Manager for the UK Equity Income portfolios. He has been managing the UK Equity Income Trust since November 2017. CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
