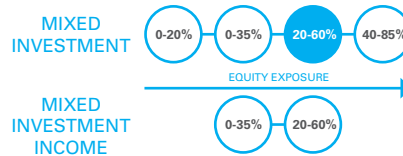

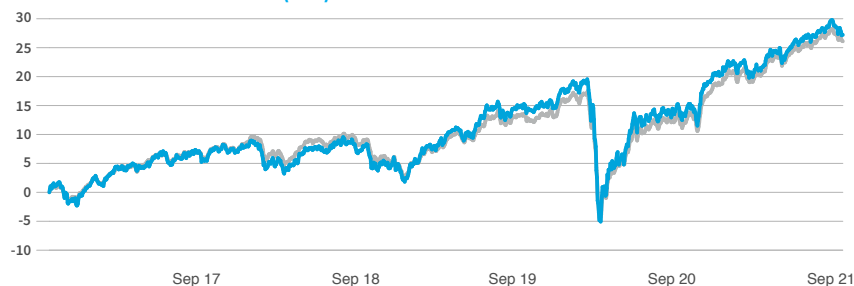

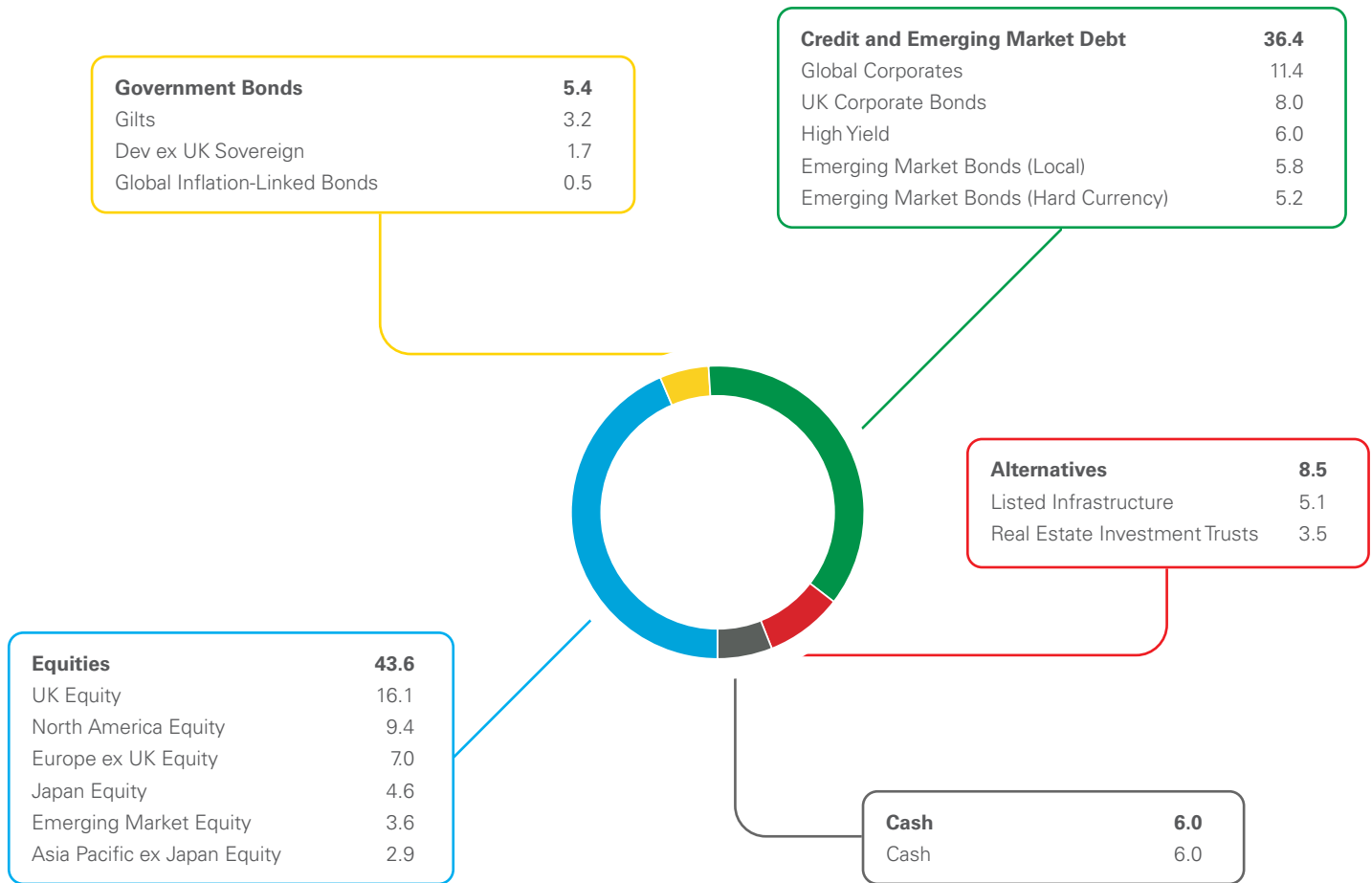
## FUND SNAPSHOT

RISK AND REWARD PROFILE

The fund is in category 4 because the mix of different asset types in which the fund invests has a balancing effect on the rate at which the fund share price moves up and down.

KEY RISKS
