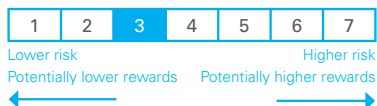

## FUND AIM

The investment objective of the fund is to provide long-term investment growth through exposure to a diversified range of asset classes, excluding physical property.

Please note that the Fund's allocation and comparator changed with effect from 31 July 2016. Comparator returns for periods starting before this date include an internally calculated composite benchmark composed of the benchmarks for each constituent fund that the Consensus Index Fund held. The Consensus Index Fund invested in a range of funds to follow the average distribution of the Balanced Fund, excluding Property as published in the CAPS Pooled Pension Fund Update.

## FUND CHARACTERISTICS

The fund will invest in a range of assets which may include equities, bonds, cash and listed infrastructure, private equity and global real estate companies. Exposure to each asset class will primarily be through investing in passively managed funds. The assets of the fund may be held directly or indirectly via units of other PF Sections, including MPAA (Multi-Asset Fund), deemed by PMC to be relevant to the objective of the fund. The fund aims to meet the criteria of the ABI Mixed Investment 40-85% Shares Sector. The fund is expected to have a level of risk which is equivalent to two thirds of the volatility of a global equity portfolio, over the long-term.

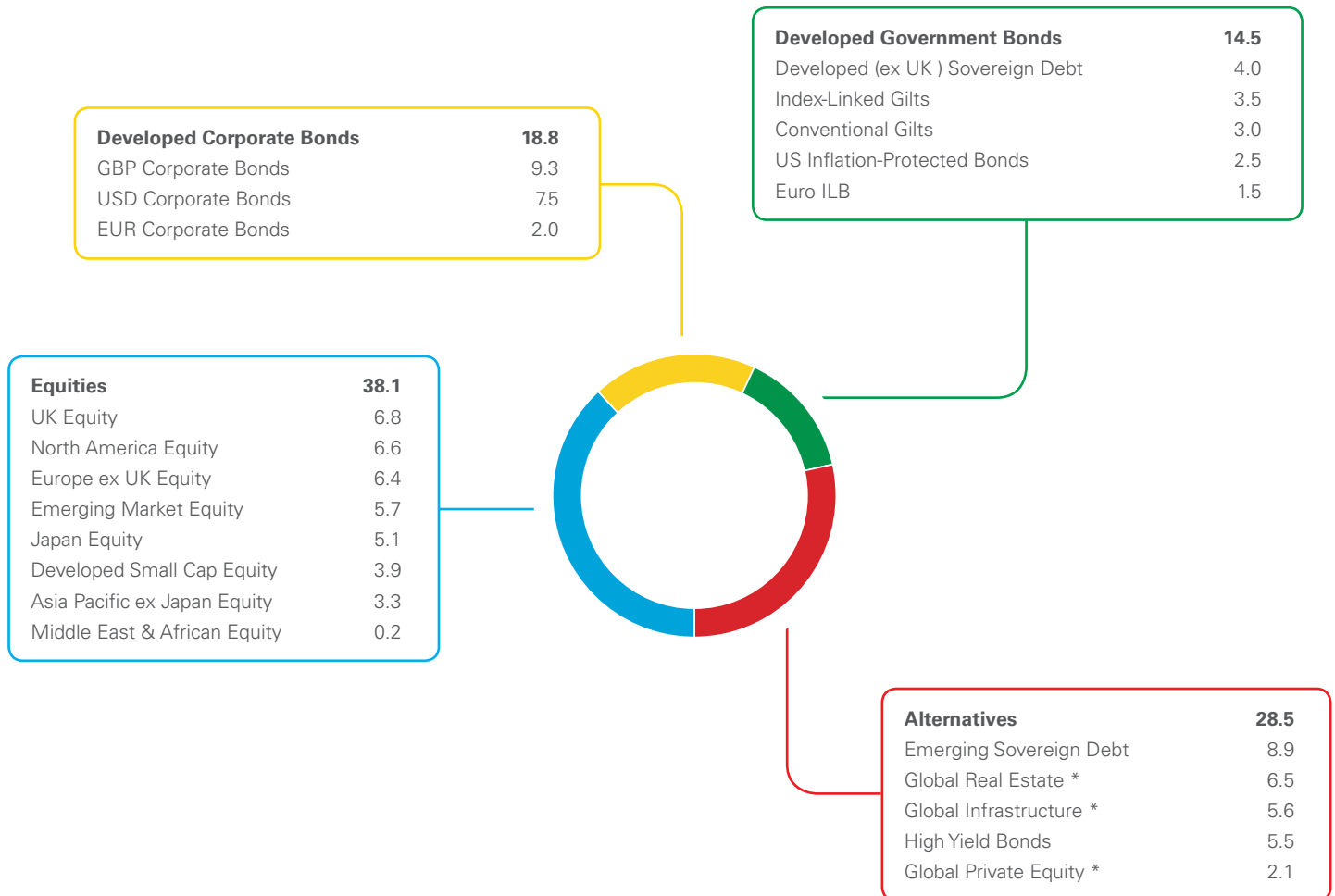
### Comparator note

The diversified nature of the Fund means that it is expected to have less exposure than a pure equity fund to adverse equity market conditions. However, the Fund may perform less strongly than a pure equity fund in benign or positive market conditions.

Please note that the performance data for the ABI Sector is on a 1 day lag and does not exactly correspond with the time period of the performance data for the Fund, the effect of this should even out over longer time periods, but may be pronounced over short time periods.

### FUND MANAGER COMMENTARY

The majority of asset classes delivered positive performance in the third quarter. Developed government bonds (both nominal and inflation-linked), investment-grade credit, and bond proxies such as listed global real estate and listed infrastructure benefitted from the collapse in yields across the globe. Trade-war news flow, weaker economic data from China and Germany, and increased concerns about the risk of a recession in the US all played a part. Indeed, August saw a commonly watched segment of the US yield curve – that between two-year and 10-year Treasuries – inverting, while 30-year US yields fell to an all-time low. Developed-market equities delivered positive returns over the period, with Japanese equities the standout performer as investors took advantage of attractive valuations. There were no changes to fund positioning over the quarter.
