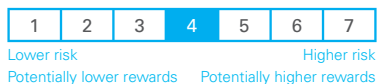

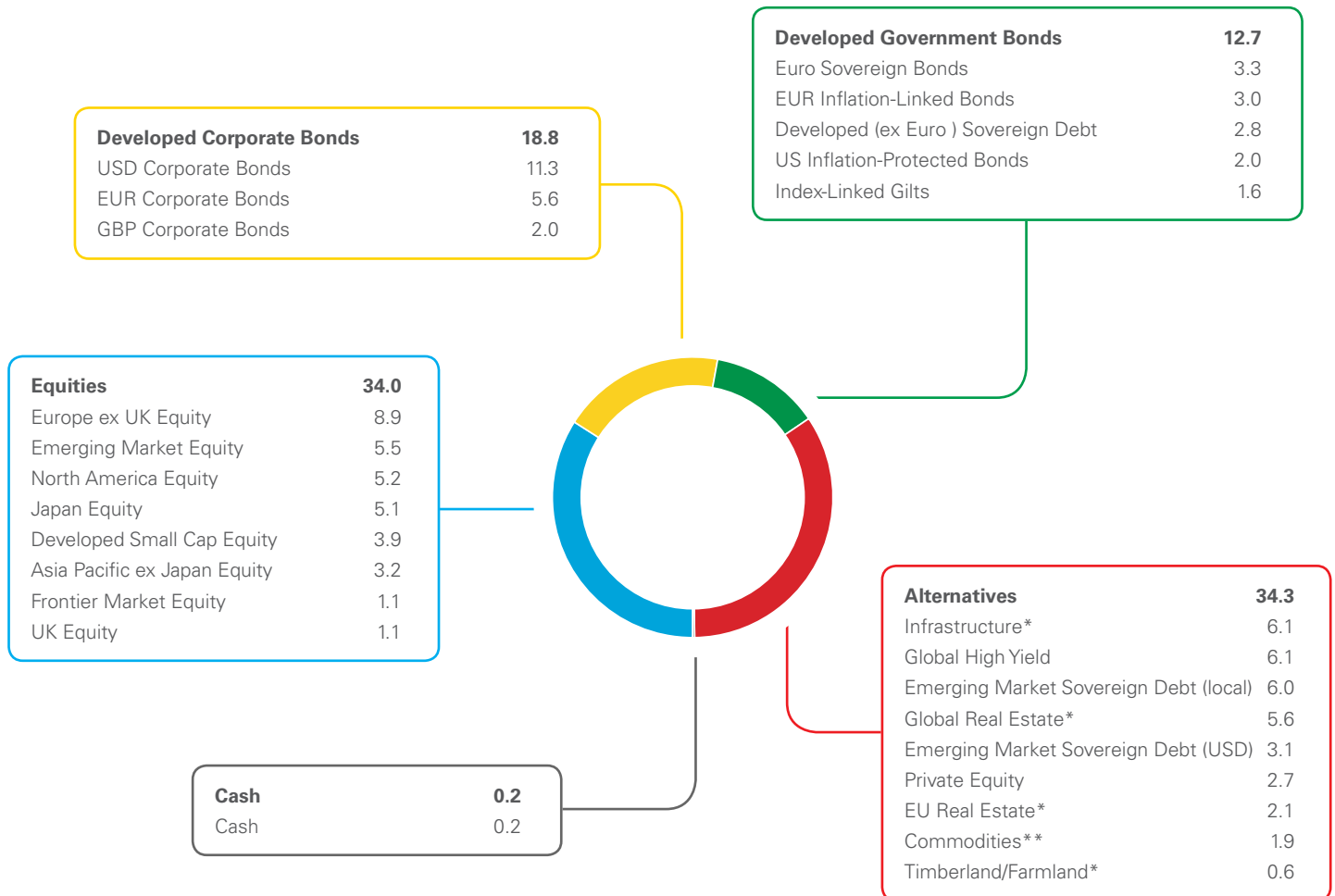

KEY RISKS
