The investment objective of the fund is to track the performance of the FTSE RAFI All World 3000 Index (less withholding tax where applicable) - GBP Hedged (with the exception of emerging markets) to within +/-1.0% p.a. for two years out of three.

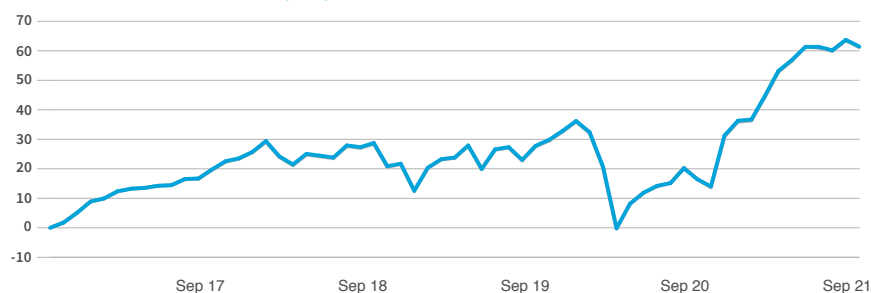
WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

The fund employs an index tracking strategy, aiming to replicate the performance of its benchmark. We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The fund may also hold index and single stock futures for efficient portfolio management. Currency hedging is employed to protect against exchange rate movements between other developed market currency exposure (except where arising from holdings in emerging market securities denominated in developed market currencies e.g. ADRs/GDRs), and selected emerging markets currency exposures are hedged back to sterling. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the fund.

Please note that with effect from 17 September 2021 the index will change to the RAFI Fundamental Global Reduced Carbon Pathway 3.5% Index- GBP Hedged and the Fund name will be amended to the RAFI Fundamental Global Reduced Carbon Pathway Equity Index Fund- GBP Currency Hedged



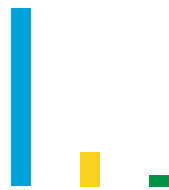
PORTFOLIO BREAKDOWN

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
