FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

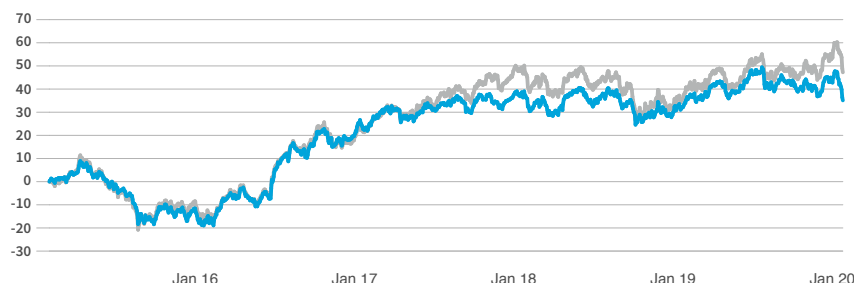

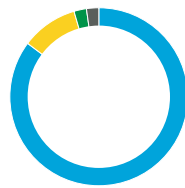

FUND MANAGER COMMENTARY

The unfortunate emergence of a significant health scare from China dented the equity rally in January. Optimism around the trade deal between the US and China was overshadowed by fears of the coronavirus outbreak, which largely led to global equity markets underperforming. Despite the best efforts of the WHO to restore some calm, panic indicators were elevated, with forecasts of a potentially large, but temporary effect on China growth. The biggest areas of concern are around disruption from travel restrictions, impact on retail and leisure spend, as well as the wider China global supply chain component.

Turning to equity market performance, Korea, Hong Kong and Macau were the biggest underperformers during January. China also endured a volatile month. Meanwhile, Australia and New Zealand outperformed. At the sector level, both Resource industries and Financials were heavy fallers. Healthcare, Technology and Telecoms were relative winners. In respect of style factors, Value was deeply out of favour relative to Growth and Quality.

The L&G Asian Income fund disappointingly underperformed, reporting a return of -5.6%. This compared to the benchmark return of -3.2%. Stock selection was negative, led by weakness in Australia, China and India. Our exposure in Financials and Consumer Services notably underperformed. Country allocation was positive, led by relative positioning in Australia and China. At the company level, Qantas Airways, Coal India, Downer, Petrochina and MGM China Holdings were the biggest underperformers. On the flipside, we saw positive contributions from Telstra Corp, Transurban and Cather Technology.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Veeral Gandhi forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.
