FUND AIM

The objective of this Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 3% per annum before charges, over rolling three year periods.

FUND SNAPSHOT

- **What does it invest in?** Invests at least 90% in shares of UK companies. The proportion of the fund invested in a company can vary between -10% and +5% of the weighting of that company in the Index.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.





FUND MANAGER COMMENTARY

Value and Recovery stocks fuelled an impressive risk-on move in equity markets during November. Encouraging news around vaccine updates and receding US political event risk drove strong equity performance in what proved to be one of the best months for global equity returns since the 1980s. Growth and Quality focused investors found relative performance tougher going, though still saw strong absolute returns. Much was a case of our secular and structural growth winners losing out in the aggressive intra-market rotation. However, whilst these companies may be vulnerable to a style rotation in the near-term, we reiterate our view that many of these stocks will also be beneficiaries of any cyclical up-turn.

The L&G UK Select Equity fund delivered a return of 10.8%, which underperformed a strong benchmark. Stock selection and sector allocation were both negative contributors in the period. For stock selection, relative weakness within financials, telecoms and basic materials detracted most value. Sector allocation also proved detrimental, driven by our underweight in the oil & gas sector. At the company level, Helios Towers, Just Eat Takeaway.com, HomeServe and Rentokil were the largest detractors on limited stock specific news. SSP Group, Wizz Air, Dalata Hotels and RHI Magnesita were all positive performers as part of the favourable recovery trade seen in November.

In terms of trading activity, we introduced new positions in Cranswick and Pets At Home following encouraging meetings with the management teams. Positions in Abcam, JD Sports and Natwest Group were sold.

Prior to this, he was a top-rated, sell-side analyst covering the Autos, Capital Goods and Conglomerates sectors at investment banks including SG Warburg (now part of UBS) and Goldman Sachs. Gavin holds a degree in Philosophy and Economics from University College, London.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS
