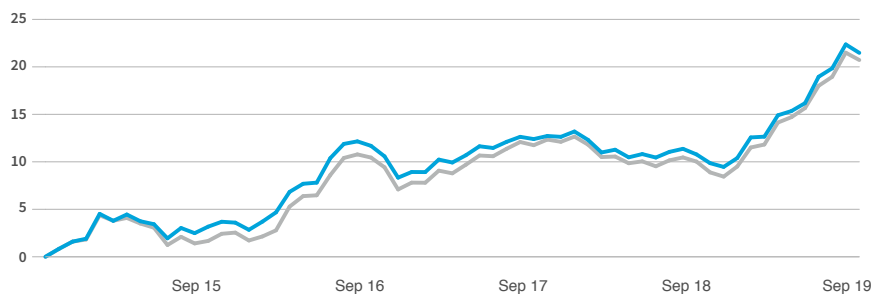
WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

The fund may achieve all or a significant amount of its exposure by purchasing shares in the LGIM Global Corporate Bond Fund which is a UCITS Compliant OEIC sub-fund. The underlying fund will principally invest in a variety of fixed, floating, index-linked and zero coupon government bonds and corporate bonds, other fixed or floating debt securities that may include Asset-Backed Securities (ABS), hybrid bonds, shares in the sub-funds of LGIM Liquidity Funds Plc. and other cash and money market instruments. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the Fund.

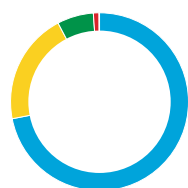

FUND MANAGER COMMENTARY

Credit markets had another positive quarter, albeit driven by the firm tone of underlying government bonds. Even with global central banks maintaining their dovish recent approach as rising trade tensions impact on economic activity, credit spreads generally widened as the increasingly uncertain outlook weighed on investors' risk appetite, with underperformance concentrated in lower-rated credits. US dollar-denominated investment grade credit outperformed its euro and sterling counterparts.

Defensive positioning, primarily through short positions in CDS indices, was a negative contributor, as CDS indices sharply outperformed physical bonds. The long position in Argentina sovereign debt also detracted. Rates positions, in particular the European flattener and long US dollar real yield positions, contributed to performance. We have focused on improving the risk profile of the portfolio, switching out of BBB bonds predominantly into higher rated credit. We increased the allocation to euro-denominated credit. From a sector perspective, we reduced consumer and telecommunications exposure, and partially covered the healthcare underweight given the sector's year-to-date underperformance.

Looking ahead, the next few weeks could be important for both the US/China trade war, and Brexit; the outcome of both will go a long way to determining the risk of recession. On the positive side, talk of fiscal support appears to be gaining momentum, and could be a key market support going forward given monetary policy is close to exhaustion. However, downside economic risks appear more immediate and still argue for a cautious global credit portfolio stance.
