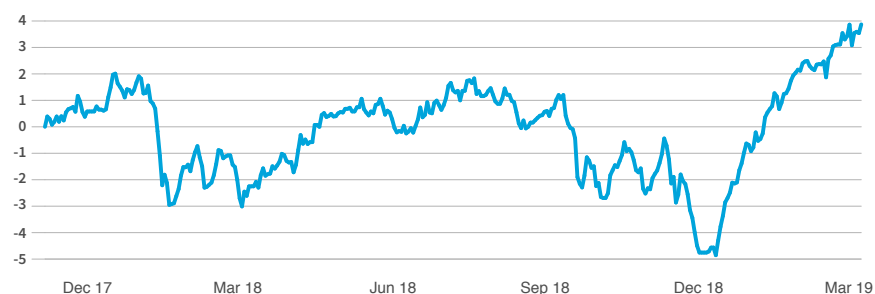

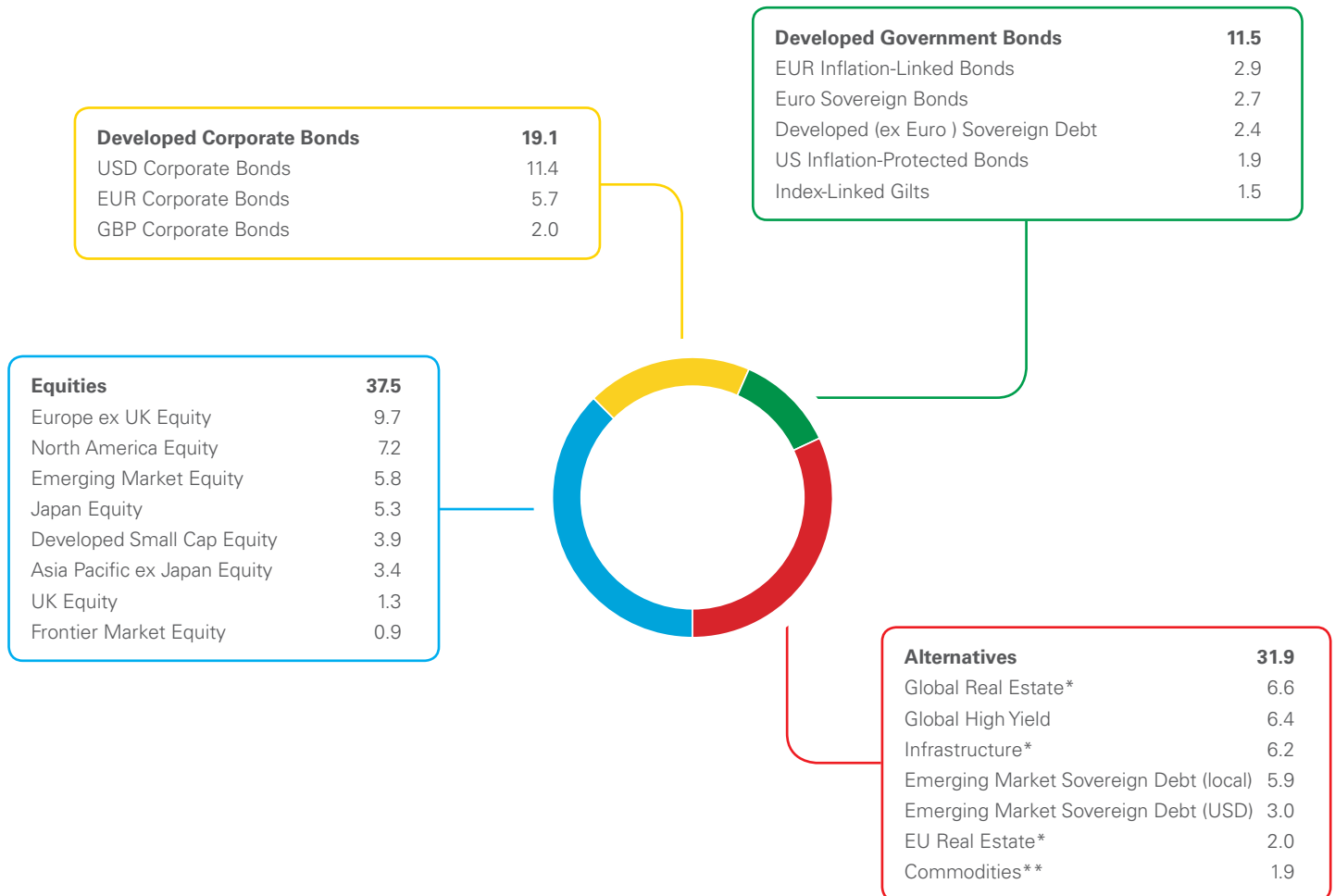

KEY RISKS
