The fund may also hold gilts to provide liquidity and to ensure that the fund's duration remains within tolerance of the FTSE Actuaries UK Conventional Gilts All Stocks Index.

Please note that with effect from 1 February 2014 the objective and investable universe of the fund changed and the fund name changed from the AAA Fixed Interest All Stocks Fund.

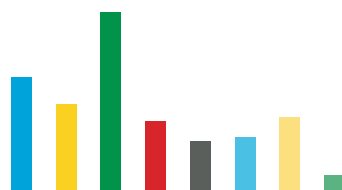

### INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
