The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

OBJECTIVES AND INVESTMENT POLICY

- The objective of this Fund is to provide growth in excess of the FTSE All Share TR Net Index, (the "**Benchmark Index**"). The Fund aims to outperform the Benchmark Index by 2% per annum, before the deduction of charges and measured over rolling three year periods.
 - The Fund is actively managed and seeks to achieve this objective by investing at least 90% in shares of companies that the Investment Manager considers to offer sustainable investment opportunities through their contribution towards the United Nations Sustainable Development Goals ("**UN SDGs**"), have strong growth prospects and are incorporated, headquartered or which have their principal business activities in the UK.
 - The Investment Manager will do so by taking into consideration the positive and negative impact that a company has from its products, solutions and/or services and business practices.
 - The Investment Manager's process to assess whether companies have a positive or improving environmental, social and governance profile is set out in the Prospectus.
 - The Investment Manager will take into consideration a company's current and future trajectory of carbon emission intensity in the overall ESG profile of a company. This is achieved by measuring the carbon emission intensity for each company in the Fund using a third party data source and considering the overall carbon emission intensity of the Fund relative to the Benchmark Index.
 - The Fund will not actively invest in companies on the Investment Manager's Future World Protection List, Climate Impact Pledge or which derive any revenue from nuclear weapons, firearms, gambling or more than 5% of their revenues from the production of tobacco or alcohol.
 - The Fund's portfolio is concentrated. Over a market cycle (typically 3 to 5 years), the Fund will comprise of 30 to 60 companies.
 - The Manager is allowed significant discretion and the weight of an individual company can represent from -10% to +5% of the Index weight. For example, if a company represents 4% of the Index, the Fund can hold from 0% up to 9% of fund assets in that company. In addition, the Manager has discretion to hold -10% to +10% of the Index weight in any sector. This will mean that the return of the Fund and the Index will be different over short periods of time and the anticipated tracking error can range from 2% to 6%.
 - The Fund may also invest in other shares (including of UK companies), collective investment schemes (including those managed or operated by the Manager or an affiliate of the Manager), other transferable securities (including participatory notes, preference shares, permitted deposits, warrants and convertible bonds), cash and near cash, and money market instruments (such as treasury bills).
 - The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:
 - reduce risk or cost; or
 - generate additional capital or income with no, or an acceptably low, level of risk.
- Other information:**
- The Fund is actively managed as the Manager uses their expertise to select investments to achieve the Fund's objectives.
 - Your units will be accumulation units. Income from the Fund's investments (dividends) will be reinvested back into the value of your units.
 - You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price.
 - The Fund's base currency is denominated in sterling (British pounds).
 - This Fund is designed for investors looking for growth from a sustainable investment approach and investment in UK companies.
 - Although investors can take their money out at any time, this Fund may not be appropriate for those who plan to withdraw their money within five years.
 - This Fund is not designed for investors who cannot afford more than a minimal loss of their investment.
 - If you do not understand this document we recommend you seek additional information to help you decide if this Fund is right for you.

- The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. 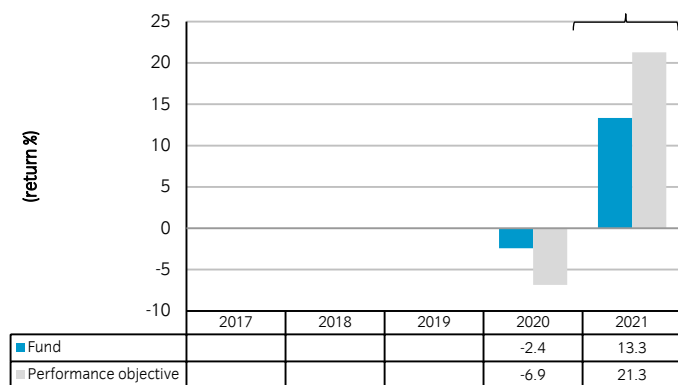
- There are no entry or exit charges.
- The ongoing charges figure is based on the latest available expenses at March 2022. This figure may vary from year to year.
- This Fund's ongoing charges include any charges made by any other funds it may invest in. They exclude portfolio transaction costs.
- The ongoing charges are taken from the income of the Fund.
- The ongoing charge for the L class covers all charges levied within the Fund. However, the Investment Management Fee is negotiated with each investor individually and is invoiced to them outside of the Fund.

Other costs:

- **Dilution Adjustment:** on any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'. This can vary but as an example for this Fund we estimate 0.54% for purchases and 0.41% for sales at 17 March 2022. The amount of the dilution adjustment may differ in future.
