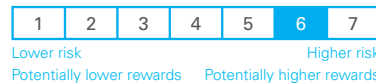

## FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

## RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

- **How does it invest?** Actively managed, with holdings in between 40 and 60 companies on average over a typical market cycle of 3-5 years.

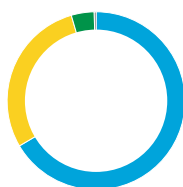

## FUND MANAGER COMMENTARY

The UK equity market performance was mostly negative amid the rise of new coronavirus cases across the UK and Europe, with many governments announcing a second lockdown. The growing prospect of a hard Brexit added to the broader uncertainty on the implications for economic recovery. More near term, the lack of fiscal stimulus ahead of the upcoming US election vote applied downward pressure on markets. In terms of economic data, August UK GDP (gross domestic product) slowed significantly, though was in line with our expectations. From a bottom-up perspective, Q3 corporate earnings have generally beaten expectations thus far, but the market appears more focused on Q4 guidance and the 2021 outlook. As such, good results are not necessarily being rewarded on results day.

The L&G UK Equity Income Fund saw a small underperformance against its benchmark. Stock selection was negative with weakness in financials and healthcare offsetting relative strength in consumer services. Sector allocation made a positive contribution, driven by the underweight positioning in healthcare and overweight positioning in Financials. By stock, the strongest performers were NatWest Group, Meggitt and Barclays. Underperforming names included BAE Systems, Imperial Brands and TP ICAP. There was no notable new activity in the period.



### STEPHEN MESSAGE

Stephen joined LGIM in 2017 as a Fund Manager for the UK Equity Income portfolios. He has been managing the UK Equity Income Trust since November 2017. Stephen joined from Old Mutual where he was responsible for the management of the Old Mutual UK Equity Income fund from 2009 until 2016. Prior to that, he was a Fund Manager at Bessemer Trust from 2006 until 2008. Stephen graduated from Imperial College London with a MEng in Aeronautical Engineering. He is also a CFA charterholder.

## ENVIRONMENTAL PERFORMANCE

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

### CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>ii</sup>.
