## FUND AIM

The investment objective of the fund is to provide exposure to the FTSE All-Share Index whilst restricting the maximum weighting of any individual stock to 5%, within a pragmatic tolerance. All remaining UK stocks are included in proportion to their weightings in the FTSE All-Share Index. The benchmark is a composite of FTSE All-Share Core Index (a customised index) and the performance of the capped single stocks.

## RISK AND REWARD PROFILE

## FUND CHARACTERISTICS

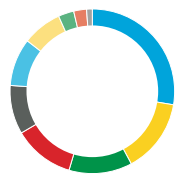
The fund invests in the UK Core Equity Index Fund and single stock UK equity funds. The underlying funds employ an index tracking strategy, aiming to replicate the performance of their individual benchmarks (less withholding tax where applicable). We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The funds may also hold index and single stock futures for efficient portfolio management.

Composite of FTSE All-Share Core Index (a customised index) and the performance of the capped single stocks

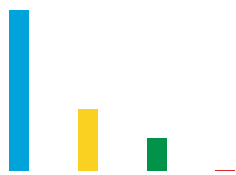

### INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
