FUND AIM

The objective of the Fund is to provide growth above that of the FTSE World Europe ex UK TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 4% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

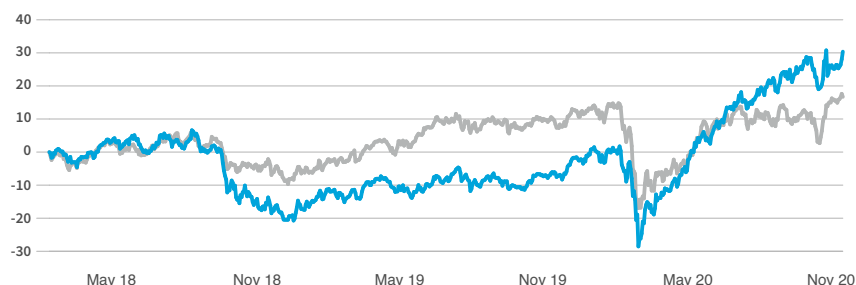

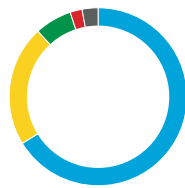



FUND MANAGER COMMENTARY

Value and Recovery stocks fuelled an impressive risk-on move in equity markets during November. Encouraging news around vaccine updates and receding US political event risk drove strong equity performance in what proved to be one of the best months for global equity returns since the 1980s. Growth and Quality focused investors found relative performance tougher going, though still saw strong absolute returns. Much was a case of our secular and structural growth winners losing out in the aggressive intra-market rotation. However, whilst these companies may be vulnerable to a style rotation in the near-term, we reiterate our view that many of these stocks will also be beneficiaries of any cyclical up-turn.

The L&G European Trust underperformed in November as part of the aggressive style and sector rotation in the period. Stock selection made the largest negative contribution, led by weakness in consumer services and technology. In terms of sector positioning, our underweight in financials was the biggest detractor. At the stock level, the biggest detractors were recent IPOs UnifiedPost Group and PharmaSGP. Other underperformers included Cellnex, Schibsted and Shop Apotheke, which have all performed strongly YTD. On the flipside, not owning Nestle and Roche was beneficial, while there were strong gains from ESG winners Infineon Technologies, Neste and Alfen.

We introduced new positions in swimming pool business, Fluidra, and digital savings and investments platform, Nordnet. Conversely, our positions in private equity manager, Tikehau Capital, and food processing company, Marel were sold.

CARBON RESERVES
