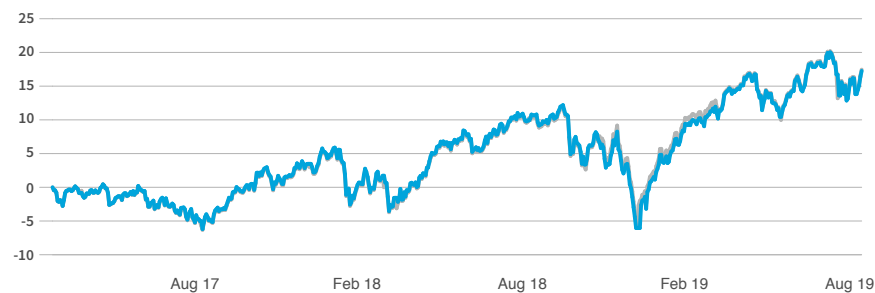

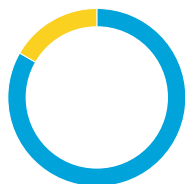

INDEX FUND MANAGEMENT TEAM
