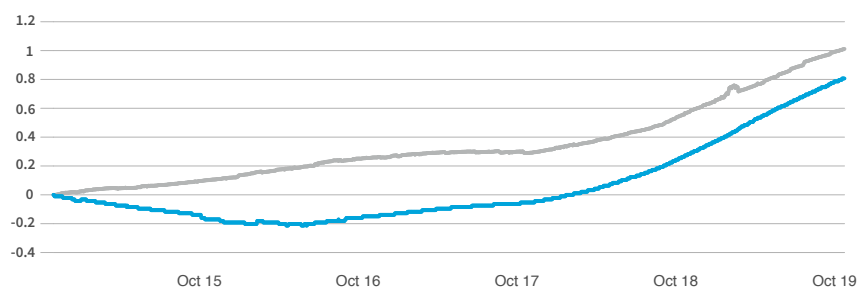

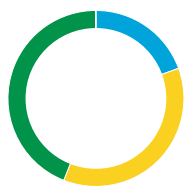
FUND SNAPSHOT

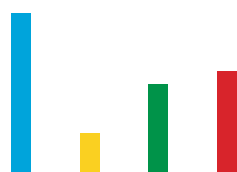
