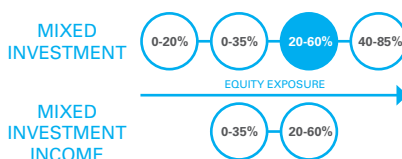

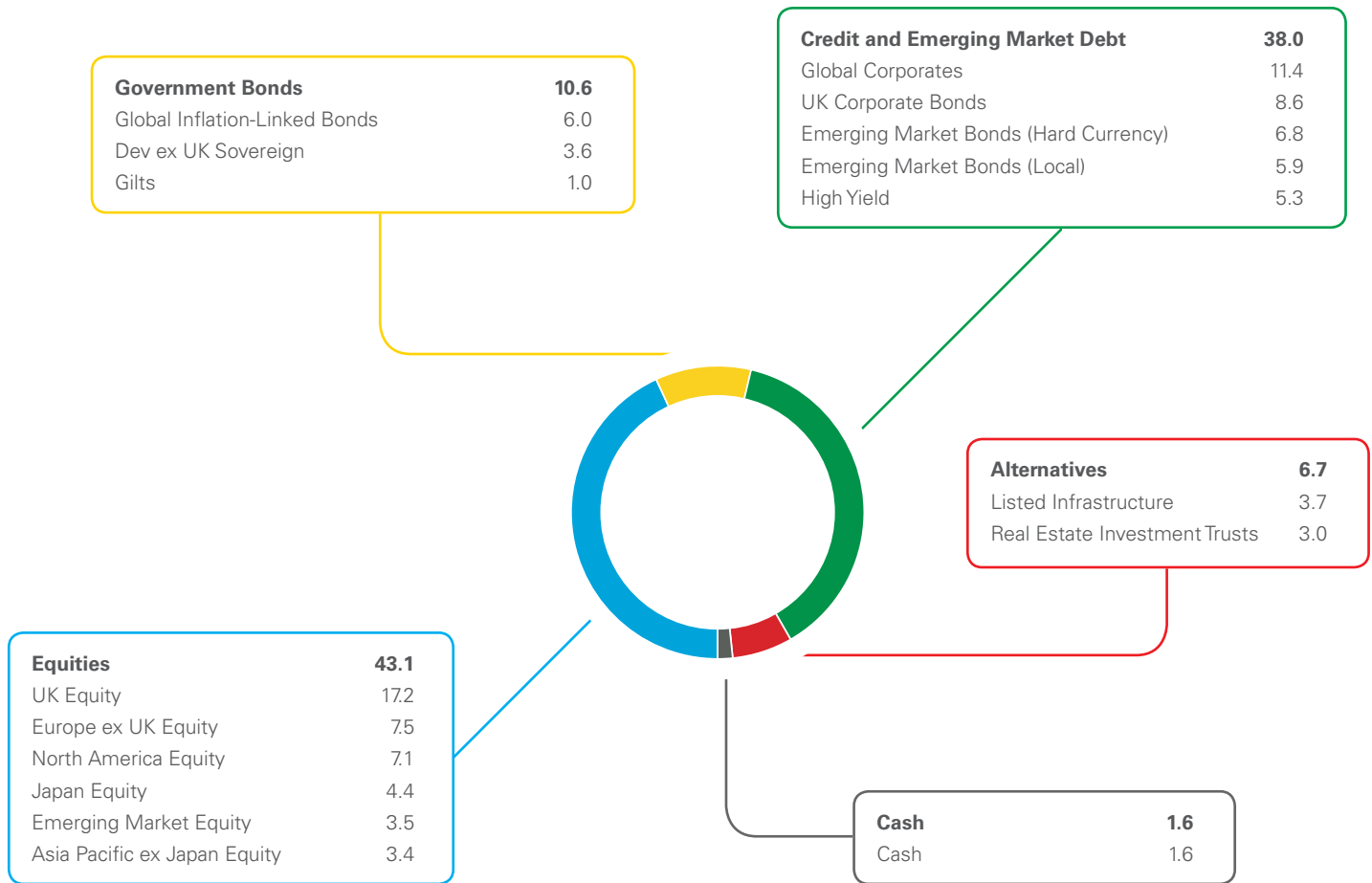
## FUND SNAPSHOT

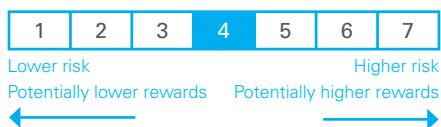
### FUND MANAGERS

RISK AND REWARD PROFILE

KEY RISKS
