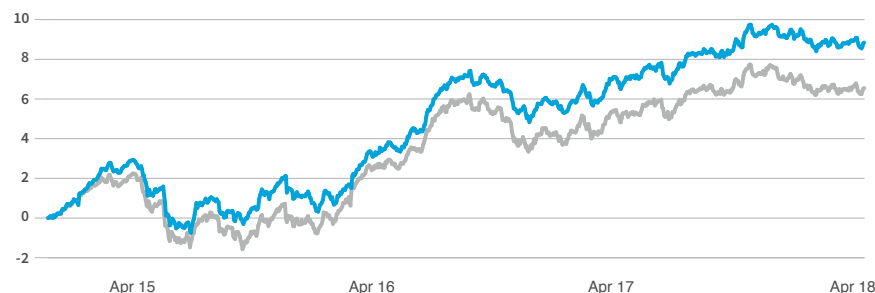

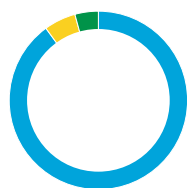

## FUND MANAGER COMMENTARY

April was a more stable month for risky assets following a weak March. Within investment grade credit euro spreads were roughly flat overall despite signs that the European Central Bank had reduced their corporate bond purchases. Sterling credit outperformed, while high yield credit was also tighter during the month.

The overall return of the index was close to zero as the limited rise in underlying yields was offset by a modest tightening in credit spreads. The fund lagged the index somewhat as sectors that underperformed sharply in March such as sub-insurance and hybrids (where we are underweight) rallied. However, fund performance was supported by our selective participation in new issuances.

With US government bond yields rising alongside the US dollar, markets are undergoing another bout of global liquidity tightening. Central banks may reduce their hawkish policy to an extent, but the direction of travel remains for tightening. This monetary tightening dynamic currently appears to be more important than the outlook for economic growth, which should remain robust in the near term though the latest weakness in euro area data and political uncertainty following the Italian elections are reason for some concern. We also expect supply to pick up in May. Combined with the ongoing reduction in monetary stimulus and geopolitical uncertainty, this may put pressure on more leveraged companies in particular, as well as names that are highly exposed to emerging markets.

## FUND MANAGERS

## KEY RISKS
