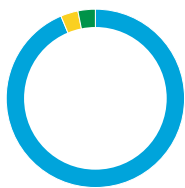

FUND MANAGER COMMENTARY

July was a much better month for risk assets. Equity markets were broadly higher, but the strength was most notable across parts of the credit space that had been under considerable pressure in recent months, particularly emerging markets. Corporate earnings have been supportive, while the technical backdrop also improved for credit markets, with supply undershooting expectations and market outflows easing considerably.

Credit spreads tightened in July following two months of spread widening. Supply was underwhelming over the month, and net year-to-date European investment grade issuance is down about 10% compared to last year. The portfolio lagged the benchmark over the month due to our cautious positioning and overweight in more defensive sectors. Our allocation to, and stock selection in the banking sector rebounded, but lagged the strong rally in insurance and commodity-related sectors.

We continue to hold a cautious portfolio stance overall despite the rally in July, with a focus on moving up the quality spectrum when we feel credit spread levels are (too) compressed. We also prefer to hold a substantial amount of liquidity (cash and bonds) given the potential for greater market issuance after the summer lull and the lower-than-usual supply since the beginning of the year.

FUND MANAGERS

KEY RISKS
