FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 4% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

FUND SNAPSHOT

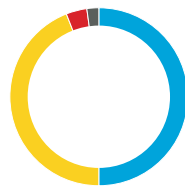
- **What does it invest in?** Invests at least 90% in the shares of UK companies that the manager believes have strong growth prospects.

FUND MANAGER COMMENTARY

Performance and sentiment surveys suggest risk appetite remains robust. For all the news around chaotic vaccine rollouts and geopolitics, the decline in volatility and broadening equity market participation reinforce the message of optimism for the days ahead. BoE Governor Bailey delivered a cautiously optimistic assessment of the path to a UK economic recovery. In other newsflow the blockage of the Suez Canal, more stories of computer chip shortages and a backlash against Xinjiang sourced-cotton were examples of how goods can be subject to unexpected disruption in supply chains.

For equity market returns, while there has been a clear 'value' rotation throughout Q1, it was interesting to see how sector and style performances of some regions were more closely bunched as the month drew to a close. In summary, it was a better period for defensive sectors like telecoms, consumer staples and utilities, in addition to cyclical recovery names within industrials, while resources struggled on relative basis.

The L&G Growth Trust delivered a positive absolute return during March, though underperformed its benchmark. Stock selection and sector allocation were both negative. By contribution, the underweight positioning within financials and selection within consumer staples were the biggest detractors. In terms of companies, Ceres Power, HomeServe, Network International and Ashtead all performed well. LSE Group, Wizz Air and FeverTree lost most value. On trading activity, we introduced a new position in fuel cell technology company Ceres Power and exited the position in e-commerce retailer ASOS.



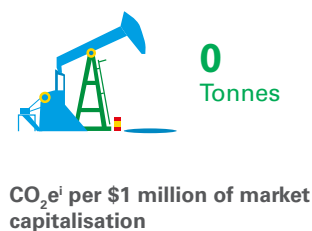
GAVIN LAUNDER

ENVIRONMENTAL PERFORMANCE

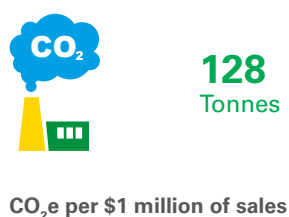
Carbon dioxide (CO₂) is the most significant contributor to greenhouse gas emissions which are driving climate change.



CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.



CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its salesⁱⁱ.
