The fund aims to produce a total return in line with the performance of the FTSE Actuaries UK Conventional Gilts All Stocks Index and capture the yield spread over gilts of AAA-AA rated fixed interest securities.

FUND CHARACTERISTICS

This passively managed fund follows a buy and maintain strategy and provides an alternative to the All Stocks Gilt Index Fund through exposure to AAA-AA rated corporate bonds that are, following issue, constituents of the Markit iBoxx £ Non-Gilts Sovereign & Sub-Sovereign AAA-AA Index. The fund may also hold gilts to provide liquidity and to ensure that the fund's duration remains within tolerance of the FTSE Actuaries UK Conventional Gilts All Stocks Index.

Please note that with effect from 1 February 2014 the objective and investable universe of the fund changed and the fund name changed from the AAA Fixed Interest All Stocks Fund.

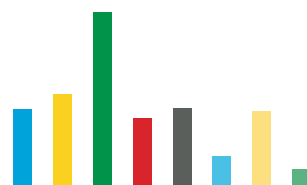

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.

KEY RISKS
