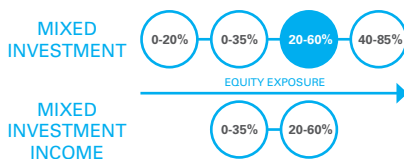

RISK AND REWARD PROFILE

KEY RISKS
