



## FUND MANAGER COMMENTARY

Emerging market debt had another weak month in November, mainly driven by the ongoing trade war concerns between the US and China. In addition, significantly lower oil prices did not help sentiment. However, total returns were supported by substantially lower US Treasury yields, which compensated for a large part of November's credit spread widening. Despite the weak sentiment, emerging market debt performed well relative to other fixed income asset classes, especially high yield debt, which sold off sharply in November.

Over the month the EMBIG Diversified sovereign index returned -0.42% (with spreads widening by 26bps) and the CEMBI Broad Diversified corporate index returned -0.21% (with spreads widening by 19bps).

The fund's performance was negatively impacted by our overweight position in Ukraine after the tensions in the Sea of Azov. Our underweight position in Mozambique also contributed negatively as the issuer and the bondholder group agreed on a restructuring which made bonds trade higher. In corporates, our overweight position in Alternatifbank of Turkey added to the fund's relative performance.



### UDAY PATNAIK

Uday is responsible for developing LGIM's emerging market capabilities within the Multi-Strategy Fixed Income team. Uday joined LGIM in April 2014 from Gulf International Bank (UK) Ltd where he held the title of Chief Investment Officer with primary responsibility for managing the flagship EMD hedge fund and other fixed income portfolios. Uday has an MBA in finance from the University of Chicago and a BSc degree in industrial management from Carnegie Mellon University.

## KEY RISKS

- This fund holds bonds that, rather than being traded on an exchange, are traded through agents, brokers or investment banks matching buyers and sellers.
