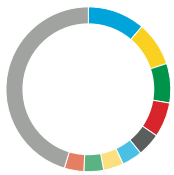

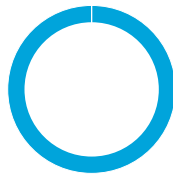

INDEX DESCRIPTION

The Index aims to track the performance of a basket of stocks of companies representing the small-cap segment of the U.S. equity universe.

The Index is comprised of the “small capitalisation” segment of publicly traded companies in the United States which is determined by: (1) ranking all of the eligible companies in descending order by reference to the total market value of each company’s shares; and (2) selecting the companies ranked from 1,001 to 3,000.

A company is only eligible for inclusion in the Index if: (1) it is of a sufficient size (determined by reference to the total market value of its shares and the proportion that are freely tradable by the public, i.e. not subject to any restrictions or fixed ownership); and (2) its share price exceeds a minimum threshold.

INVESTMENT MANAGER

GO ETF Solutions LLP is the investment manager for each of the exchange traded funds (ETFs) issued by Legal & General UCITS ETF Plc and is responsible for the day-to-day investment management decisions for this ETF. The team is highly experienced with respect to all aspects relating to the management of an ETF portfolio, including collateral management, OTC swap trading, adherence to UCITS regulations and counterparty exposure and monitoring.

KEY RISKS
